ANZAC DAY REPORT

- a. Paul O advised that the ANZAC Day Service was a success from the feedback he had received from veterans at the service and other participants.
- Padre Richard Thornton noted the following from the Committee Meeting Minutes 6 May 2025.
 - 1. He was not happy with the comment about singing and not knowing the words for the National Anthem and confusing the audience, he advised he was a trained singer.
 - He also wanted a pre planning trial before the official Service (maybe three days before the event), so everyone was on the same page. Much discussion ensued, but all members thought this was a good idea.
 - 3. Laying of Wreaths, Richard thought it would be dishonorable to not name those laying wreaths, but thought a more efficient way of calling up wreath layers need to be investigated based on his experience. All thought his ideas should warrant investigation.
 - 4. Richard made a request to all members and the President if his ANZAC Day Service was acceptable. Paul O confirmed it was most appropriate, and all members agreed.
- c. Ray Bale who was the MC for the ANZAC Day service, responded to Richard and advised he did not mean the audience was confused but in fact himself (also a trained singer) who was singing the National Anthem and due to background singing near him (found this distracting.). Richard and Ray both agreed a pre planning trial before the Service could iron out these minor problems.
